First of all, improve the early warning mechanism, usually pay attention to students' feedback and bad emotions, behavior, pay more attention to this kind of students, identify, diagnose, predict possible problems, and formulate the corresponding treatment plan, function distribution, work countermeasures.

Secondly, establish the working mechanism of quick response and effective communication. After the occurrence of an emergency, the relevant working group of the school should clearly guide the direction and countermeasures, and then quickly organize the personnel to deal with the incident, control the public opinion, and avoid the occurrence of false statements or lead to the rapid spread of rumors. The personnel should communicate quickly and coordinate with each other through building groups. Finally, we should improve the work of ideological and political rule of law education, in the daily curriculum, more comprehensive guidance to students to develop good behavior and psychology, in addition, we should optimize the management system, evaluation mechanism, incentive measures to solve the ideological education lag, unreasonable management, unfair handling and other issues.

## 3.4 Build the monitoring system of public opinion, and build a new position of ideological and political rule of law education through network channels
