The government's timely disclosure of information can quickly quell social rumors, calm people's hearts, increase the people's support, understanding and cooperation with the government's handling of affairs, enhance the good image of the national government, and highlight the legality and compliance of the use of police force in crowd-related incidents; At the same time, it has also put an end to the government's abuse of power in emergency situations and the occurrence of corrupt behavior, further eliminating the indignation of the people, and avoiding the intensification of conflicts between the government and the people.

3. Effective ways to realize information disclosure in mass incidents

3.1 The government actively changes its concepts and strengthens the autonomy and authenticity of information disclosure

The people are the masters of the country, and the government is the government of the people. As the people's government, it must replace the traditional bureaucratic thinking and one-sided stability maintenance mentality, always establish a sense of open government administration, and establish a sunny government law enforcement agency. Therefore, as a government department, it is necessary to actively strengthen the transparency of information disclosure, and must not deliberately conceal, block or lie about information, so that true and comprehensive information can be accurately and timely transmitted to the masses, so as to correct false information, calm tensions, and eliminate parts. The irrational emotions and behaviors of the crowd. In this way, the people's heartfelt conviction is ensured, their right to know is ensured, the people's trust and positive energy are expanded, and the occurrence of corruption is effectively prevented. At the same time, the government must reflect the governance goal of "all for the people's livelihood", actively establish a governance-oriented government, change the role of the government from a manager to a service provider for the people, and actively enhance the service awareness of public information in crowd incidents. The crowd takes the initiative to disclose information. Therefore, as a government, it is necessary to always establish a concept of responsibility, leading the people to be held accountable to the end, fully aware of the responsibility and obligation of publicizing information in crowd incidents, and should not give people their rights as their own privileges and restrict information resources. It is true that the people are more eager to learn about the real problems of the incident itself by citing some false and untruthful information about his resignation, and hope that the government will dare to take the responsibility to deal with it and be a government trusted and loved by others.

3.2 Improve laws and regulations on information disclosure

Organized. Furthermore, the state must formulate matching laws and regulations. When dealing with mass incidents, information disclosure is a procedural and complex process. The content, scope, process, disaster relief, supervision, etc. of information disclosure must be based on relevant laws. Implementation must highlight information. Therefore, we must be cautious, comprehensively consider the establishment of comprehensive information disclosure laws and regulations, coordinate the adaptation relationship between laws, and make practical use needs.

3.3 Complete and complete information management system

The government should establish a professional information management agency, unify information disclosure channels, avoid the confusion of information disclosure, cause information disclosure to lag and replace, so that relevant information in mass incidents can be smoothly disclosed and shared, thereby improving the government’s handling The efficiency of information disclosure in crowd incidents, reorganization and timely handling, resolve the effective role of mass incidents. In addition, the government needs to further improve the information disclosure coordination system, sharing system, and formulate information and intelligence early warning mechanisms. After mass incidents occur, news reports, government websites, and government officials and micro-organizations must jointly promote the positive development of the incident and play a role. The combined effect of information disclosure. Therefore, it is also necessary to eliminate local protectionist ideology, allow these relevant departments to exchange and share information, and strengthen the coordination of various departments in information disclosure.

3.4 Establish an accountability management mechanism for information disclosure

The government should strengthen the evaluation effect of the information disclosure work. After handling the mass incident, the relevant government regulatory agencies and social groups will conduct an objective and comprehensive evaluation and review of the information disclosure work in the incident, including the various aspects of information disclosure. Possibly, reasonably, reasonably, and comprehensively evaluate the handling of information disclosure, such as the good response after the disclosure, so as to summarize the valuable experience and education of handling crowd events in order to make a difference in future work. Improve. Furthermore, a comprehensive information disclosure accountability and supervision mechanism shall be formulated. Whenever illegal and compliance behaviors are found in the information disclosure work, the people can file a complaint with the regional special regulatory agency and the judicial department and obtain timely handling in accordance with the law. Laws and regulations, in accordance with the responsibilities of individual supervision of government departments, strengthen the internal management of the government, and carry out the disclosure of information in the handling of crowd incidents by judicial departments, news, and public opinion. Issues impose regulatory pressure to ensure the smooth and effective development of information disclosure.
