## 2. Problems in the cultivation of college students' rule of law literacy

## 2.1 College students' rule of law literacy needs urgent improvement

Some college students think that the law is far away from their lives, and their understanding of the rule of law is superficial, one-sided and simple, which leads to the lack of enthusiasm to actively learn the knowledge of the rule of law, resulting in the lack of cognition of the rule of law, unstable belief in the rule of law, weak thinking of the rule of law and other phenomena.

# 2.2 The cultivation of college students' legal literacy is Insufficient

The lack of effort and attention to the cultivation of rule of law literacy among college students in some colleges and universities is another hindrance to the cultivation of college students' rule of law literacy. It is mainly manifested in two aspects: Firstly, the cultivation of college students' rule of law literacy lacks systematization. It is very fragmented and the course of rule of law education for non-law students is relatively single, mainly the course of "Ideological Morality and Rule of Law" opened in freshman year. It is generally limited to teaching some basic knowledge of law and less for the part of law and the learning time. In the limited teaching, there will be a problem of tight class hours and heavy tasks, and it is difficult to teach students according to their aptitude and resulting in poor teaching effect; Secondly, the cultivation of college students' legal literacy lacks practicality. At present, the cultivation mode of college students' law literacy is mainly based on the indoctrination of legal theory knowledge, which is limited to classroom teaching. This makes practical education insufficient

and lacks ways to train college students' rule of law literacy in practice, resulting in a certain degree of disconnect between college students' theoretical ability and practical ability in the rule of law, so that making it difficult to externalize the legal knowledge they have learned and unable to scientifically, timely and accurately apply rule of law thinking, rule of law ability and rule of law means to solve the difficulties they encounter.

#### 3. The path of cultivating college students' rule of law literacy

#### 3.1 Activating college students' consciousness of rule of law

The cultivation of college students' law literacy should focus on activating their legal consciousness and cultivating their legal thinking. It will make them rise from the knowledge level of knowing the law to the level of consciousness such as rule consciousness, democracy consciousness and responsibility consciousness, so that the value implication of the rule of law such as freedom, equality, fairness and justice is internalized in their hearts and form a solid and conscious rule of law consciousness and rule of law thinking.

### 3.2 Cultivating the foundation of rule of law literacy through curriculum

First of all, ideological and political courses should play a leading role as the main channel of legal education. Taking Xi Jinping's thoughts on the rule of law as the guidance of the times, combining the characteristics of the curriculum, integrating rule of law education into classroom teaching, , so as to timely convey the theory and spirit of the rule of law to students and reflect The Times of education. Secondly, by setting up law-related courses, inviting well-known experts, scholars and legal practitioners to give lectures on cases. The content should mainly focus on knowledge relevant to college students such as beware of employment traps and new types of frauds to effectively help college students cope with difficult problems in their lives and improve the relevance of education.

## 3.3 Innovating the practice form of cultivating law literacy

The rule of law literacy of young students also needs to be improved and improved in the process of understanding national conditions, deepening reality and participating in practice. The society, government, enterprises, mass organizations and colleges and universities should work together to expand the channels of practical education. Through the construction of practical education base, students are encouraged to actively participate in off-campus social practice and rewarded by comprehensive assessment. Such as Organize students to become volunteers in community law popularization, lead students to conduct off-campus law preaching, guide students to participate in public legal aid and arrange students to go to judicial organs for internship. In this way, college students will be placed in the atmosphere of the rule of law society, participate in the construction of the rule of law in society, test their knowledge and improve themselves in practice. At the same time, the campus cultural activities and campus network should also be infiltrated with rule of law practice activities, such as regular mock courts, legal knowledge competitions, legal advisory services and other activities, and take "12-4" National Constitution Day as an opportunity to carry out education activities on the theme of National Constitution Day, so as to nourish the rule of law literacy of college students in practice.
