The Civil Code is known as the encyclopedia of social life. It is the first law named after the code in New China, and it occupies a fundamental position in the legal system of our country. For example, the principle of equality corresponds to the equality of the core socialist values, the principle of voluntariness corresponds to the freedom in the core socialist values, and the principle of fairness corresponds to the core socialist values. Freedom, democracy, the principle of good faith corresponds to the integrity in the core socialist values, and the principle of law-abiding and public order and good customs corresponds to the rule of law and harmony in the core socialist values, the green principle corresponds to civilization and friendliness in the core values. The basic principle of the "Civil Code" is the general expression of the core socialist values in the civil law. The development of civil code education in universities is conducive to further promoting the practice of the core socialist values. The principles, regulations and innovations of the Civil Code can reflect the core values of socialism, show the social value orientation of advocating morality for goodness and promoting virtue, and have attracted widespread attention and imitation from all walks of life, and can also promote the good moral outlook of college students Shaping and cultivating.

### 1.2 The education of the University's Civil Code is conducive to the cultivation of college students' thinking on the rule of law.

Through the civil public interest litigation cases of heroic martyrs protection, the behavior of infringing on the reputation of heroes is punished, which reflects the value orientation of patriotism, is conducive to establishing a correct social atmosphere of respecting and admiring heroes, and can arouse college students' sense of respect for idols And their own value pursuit. The case-based teaching method of ideological and political education in the Civil Code vividly and intuitively presents the operation of civil law in society, which will make students truly feel that civil law is around, and let students learn, understand, believe and use the law. In the course of teaching, teachers can group in the form of groups, conduct sufficient group discussions on cases, publish their views on case studies, inspire students to collect more typical cases after class, and broaden classroom capacity.
