For American educational system, they pay much attention to qualify-oriented education. All states in America require young people to attend school. And different standards vary in different states. It is recorded that 32 states require attendance to age 16. While the other 8 states require attendance to age 18 and so on. Thus, every child in America has almost 13 years to finish his/her study. Americans have a strong tendency to make their children aware of the importance of important social problems concerned by people.

When talking about levels of schooling, they have to enter elementary school until grades K-6 or K-8. After that, children in America have to attend secondary school lasting for 4 years of formal education from grades 9 to grades 12. Another characteristic is that there is no national curriculum in the United States and certain subjects are taught in all K9 to 12 systems across the country. Almost every elementary school provides instruction in these subjects: mathematics; language arts including readings, grammar, compositions and literature; penmanship; science; social studies including history, geography, citizenship and economics, music, art and physical education.

From a large perspective, research on the history of education is going out of the country and studying the whole world's educational history as a whole. It not only focuses on the development of educational history in the US, but also extends the research perspective to other countries in the world. The mode of learning, focusing on solving problems rather than memorizing theory, became popular in America. Many science courses are added to the curriculum.

Education in the United States is held for every person in society not specifically designed for few people. They held using tax for free education, sewing, typing, wireless and automotive repair and other subjects besides general school subjects such as math, history and language. Students are able to choose a large number of subjects according to their own interests, personal plans and talents by themselves.

From the perception of history and culture, British education has a very long history and its early education has its own system, focusing on the personalized training and all-round development of students; Emphasizing "elite" education, the top aristocratic schools headed by Eton College have cultivated a large number of political and business elites.

While America is a country of immigrants, it pays more attention to multicultural education. Puritans also set up a system of education in their colonies and declare that all property could be taxed for the common good including the support of schools.
