Research on "one-stop" student community education mode under the perspective of "three full education"

Finally, we should pay attention to the individual differences of students. Each student is a unique individual with different growth rates, interests and directions. 3. Optimize the work flow of community services and improve the quality of one-stop services

For example, community personnel can solicit opinions and suggestions from students, get feedback from students, and solve practical problems of students in a targeted way to improve students' satisfaction. For example, they can provide students with psychological counseling, life counseling and other services, so that students can get all-round support in the community. For example, improve the professional quality and service awareness of service personnel, strengthen the supervision and management of service process, and ensure the quality and effect of service. Finally, reflect the individuation of one-stop service. For example, in community management, students' self-management ability should be brought into full play, and the students' self-government committee should be responsible for the daily management of the community and the organization of activities, so as to encourage students to actively participate in community activities. School counselors should go deep into the student community, guide students to correctly handle interpersonal relationships, resolve conflicts between students, strengthen the guidance and management of students' behavior, ensure that students can grow healthily and develop comprehensively in the community, and maintain the harmony and stability of the community; School administrators should take the initiative to pay attention to the ideological dynamics of students in the community, find and solve problems in time, and provide effective support and help for the comprehensive development of students.
