3.2 The negative influence of network public opinion on public policy making

However, the elderly and juvenile groups, or limited to knowledge, ideas, and physical reasons, are difficult to participate in the way of network participation. Or limited to family and learning reasons, it is difficult for juvenile groups to use the Internet for a long time, and there is no way to talk about online public opinion. In addition, the network public opinion also reflects the regional imbalance. The number of Internet users in urban areas and developed areas far exceeds that in rural and underdeveloped areas.

4 Strategies for optimizing citizens' participation in government public policymaking

4.1 The government strengthened the construction of network platform

With the rapid development of Internet technology, more and more citizens make their own voice through the network. The government should ensure the construction of information technology infrastructure, vigorously promote the development of network informatization and let more people enter the Internet. We should promote the construction and development of e-government, implement network politics through the establishment of government website, conduct direct dialogue and communication with netizens on microblog, WeChat, forum and other network platforms, listen to citizens' opinions and respond in time, effectively strengthen the guidance of network public opinion, and play our leading and exemplary role^[5].

4.2 Give full play to the role of network media organizations

As an important part of network society, the orderly and healthy development of network media organization plays a vital role in network public opinion and even government public policy. Its reporting and processing of social events affects the thinking and judgment of Internet users to a great extent and takes it as the communication carrier to further ferment citizens' opinions and suggestions, thus forming a huge network public opinion, forcing the government not to pay attention; Secondly, the network media itself has the advantages of flexibility and timeliness. It can spread the news at the first time, which makes up for the lack of government management to a certain extent.

4.3 Improve citizens' online participation literacy and participate in an orderly manner in accordance with the law

With the continuous development of democratic politics, people pay more and more attention to their own rights and interests, and their desire to express public opinion on the Internet is becoming stronger and stronger. Network public opinion has gradually become one of the important ways for people to express their demands ^[6]. The government should give full play to the role of publicity and guidance, improve systems and rules, make the people recognize the importance of political participation, lead the people to reasonably express their demands, promote the improvement of the people's overall political literacy, and stimulate the citizens' enthusiasm for participating in and discussing politics. The government should take more responsibility, improve the education and training of network political knowledge, and effectively guide citizens to participate in the network legally and orderly, so that the network public opinion can play a more orderly, efficient, and rational role in the government's public policy.
